## Golden Gate Avenue Mainline Rehabilitation

Summerland Sanitary District contracted Tierra Construction to perform a mainline rehabilitation project on Golden Gate Avenue. This extensive project involved the repair of a pipe offset in the District's collection system that was located eighteen feet underground, between two manholes. A new section of PVC pipe was installed to replace the old section. The project was successfully completed on July 17, 2020.

## District's Outfall Pipeline Repair

Every year the Summerland Sanitary District schedules a visual underwater inspection for the District's ocean outfall to note its structural integrity, fractures, or any potential malfunctions. This annual inspection is a requirement for the National Pollution Discharge Elimination System (NPDES) permit. On August 10, 2020 Salty Dog Dive Service was contracted to perform the District's outfall inspection. While the overall condition of pipeline was satisfactory, a small fracture was discovered around one point of the pipe. To prevent the fracture from expanding, Summerland Sanitary District contracted Harbor Offshore to install a twelve-inch stainless steel repair clamp. The stainless steel repair clamp was successfully installed on September 18, 2020.
