Treatment Plant Tours

Dear Summerland Sanitary District Customers;

The Summerland Sanitary District (SSD) is committed to serving the needs of the Summerland community with a reliable cost effective wastewater treatment facility. The District is governed by a Board of Directors consisting of five members elected at large. The District derives its authority in the California Health & Safety Code (Sec-6400-6830), operates under the State Water Quality Control Board National Pollutant Discharge Elimination System (NPDES Permit #CA0048054), is independently audited and subject to state and federal regulations.



The Board members and staff would like to invite you to take a tour of the facility and meet the hard working group of people that keep this well-oiled machine running. It is an opportunity to get to see our current projects and give us any feedback you may have. The District uses the highest most advanced treatment processes available. Discharged water samples are tested daily by staff and sampled every other day by an independent laboratory. This treatment process train includes preliminary treatment, primary treatment, secondary treatment (which uses micro organisms to clean the water), tertiary filtration with an anthracite coal filtration bed (similar to what is used in large aquarium's), chlorine disinfection and de-chlorination to produce one of the finest effluents prior to final discharge into the Pacific Ocean. Other wastewater treatment facilities on California's coast do not come close to Summerland's advanced process, which is why the Summerland Sanitary District has been awarded Plant of the Year by the California Water Environment Association in the past. This award is given to the best overall treatment facility within Ventura, Santa Barbara and San Luis Obispo counties. The entire collection system which includes all of the mainline pipes, lift stations and generation stations are also maintained by District staff, which includes lines cleaning, closed circuit televising as well as point repairs, manhole adjustments and large construction inspections. The SSD team works very hard to provide excellent service to its customers and is always focused on protecting water quality and public health.

Speaking of awards, the Summerland Sanitary District has been awarded the 2019 prestigious certificate of excellence from the Special Districts Leadership Foundation. The award is given to California special districts that exemplify essential governance transparency requirements. The entire staff as well as the board of directors are to be commended for their contributions that empower the public with information, facilitate engagement and oversight.
