RE: Wallace Avenue Main Sewer Line Emergency Repair

REQUESTED ACTION: For the Board of Directors to declare an emergency with regard to the repair of a certain section of the main sewer line located between manhole R9054 and R9053 and authorize remedial work to be performed without competitive bidding.

INFORMATION: Summerland Sanitary District has a collection system that was originally installed in 1957. Most of the collection system is made up of vinyl clay pipe and the rest varies from cast iron, PVC, and asbestos cement. Although the collection system is of old age it has been determined through staff closed circuit televised inspections that the majority of the mainlines that have been inspected are in good condition. Videoing of the collection system is prioritized by its use and staff observation. For example, the mainlines that carry higher flow and higher fats, oils, and grease concentration have higher priority than those mainlines that do not. As for staff observations, whenever staff experiences complications with cleaning a mainline during routine maintenance, that specific mainline is videoed subsequently to determine the cause of the complication.

Recently, staff performed routine mainline cleaning between manhole R9054 and manhole R9053 and experienced difficulties retrieving the jetter nozzle.

Staff subsequently conducted a video inspection of the main sewer line located at Wallace Avenue, between the previous mentioned manhole R9054 and manhole R9053 (see atlas page R9NW). The video inspection showed an offset and a severely cracked main sewer line prompting immediate action for repair to prevent the section of pipe from collapsing and creating a sanitary sewer overflow (see main sewer line snapshots).

RESOLUTION NO. 2021-10

RESOLUTION OF THE GOVERNING BOARD OF DIRECTORS OF THE SUMMERLAND SANITARY DISTRICT DECLARING AN EMERGENCY REQUIRING REPAIR OF A CERTAIN SECTION OF THE MAIN SEWER LINE, AUTHORIZING REMEDIAL WORK TO BE PERFORMED WITHOUT COMPETITIVE BIDDING, DECLARING THE PROJECT TO BE EXEMPT FROM THE REQUIREMENTS OF THE CALIFORNIA ENVIRONMENTAL QUALITY ACT, AND MAKING NECESSARY FINDINGS THEREFOR

WHEREAS, the Summerland Sanitary District ("District") owns and operates its treatment facility ("treatment plant") at 2435 Wallace Avenue, Summerland, California; and

WHEREAS, the Operations Manager has noted specific conditions in the District's collection system at a certain section of the main sewer line located 16 feet underground, between manhole R9054 and manhole R9053, showing a significant offset and crack in such a manner that the offset and crack could lead to a sanitary sewer overflow, which constitute a possible public health and safety hazard, warranting immediate repair; and

WHEREAS, these existing conditions affect the public interest and necessity demands the immediate expenditure of District funds to safeguard life, health, and property for this "emergency" under section 20806 of the Public Contract Code; and

WHEREAS, these existing emergency conditions will not permit a delay resulting from a competitive solicitation for bids for the corrective action ("Project"), and immediate action is necessary to respond and allowed under section 22050 of the Public Contract Code; and


NOW, THEREFORE, the Board of Directors hereby resolves and finds as follows:

- An "emergency" exists within the meaning of section 20806 of the Public Contract Code and public interest and necessity demand the immediate expenditure of District funds for the Project to safeguard life, health, and property.
- 2. Under subsection 22050(a)(2) of the Public Contract Code, the emergency cannot be redressed properly if delayed by competitive bidding and solicitation and immediate Project commencement is necessary.
- 3. Pursuant to subsection 22050(b)(1) of the Public Contract Code, the Board directs the Operations Manager to immediately proceed with and expend funds for the Project, without giving notice for competitive bids.
- 4. This Resolution's recitals are incorporated herein by reference and adopted as findings.









SCOPE OF WORK

Wallace Avenue Emergency Sewer Main Repair

Tierra Contracting Inc. will provide all labor, material, equipment and traffic control to make emergency sewer repair on 8" VCP sewer trunk main on south side of Wallace Ave in Summerland.

 Construct and install sewer bypass system. Flow through sewer plug inserted into upstream manhole R9054 will be plumbed into approximately 220 LF of 3" fused DR17 HDPE pipe with inline 3" trash pump that will bypass the existing sewer main above ground and discharged into downstream manhole R9053.

Bypass Cost = \$5,750

2.) Mobilize, clear area of bushes and shrubs above area of excavation, pothole any existing utilities that may be in conflict. Excavate and shore down to sewer main break, remove and replace existing failed sewer pipe with new SDR35 sewer pipe from inside of upstream manhole R9054 to approximately 10 LF east of manhole and connect to where existing main is in acceptable condition. Enter manhole using proper confined space entry equipment in order to replace mortar/concrete at point of entry for new 8" pipe. Backfill and compaction per County of Santa Barbara standards. All sewer work to be done per Summerland Sanitary District standards.

Repair Cost = \$26,795

Total Cost = \$32,545

General Bid Excludes: Fees, Plans, Permits, Staking, Landscaping, Soil Testing, Additional Move-ins, Responsibility for damage to all unknown/unmarked existing onsite utilities, Winterization of Project (Sediment Control-Strawbale Barriers around Catchbasins), Storm Water Protection Plan, all costs associated with contaminated soil or ground water.
